THE BUTTE COUNTY COMMISSIONERS CONVENED AT 9:36 A.M. June 1, 2010. Commissioners present were Kindsfater, Smeenk, Harms and Hansen. Chairman Kling was absent.

Vice - Chairman Marvin Kindsfater called the meeting to order and led the group in the Pledge of Allegiance.

Motion by Hansen Second by Smeenk to approve the meeting agenda as presented. Vote Unanimous. Motion Carried.

Motion by Hansen Second by Smeenk to table the minutes until the next meeting. Vote Unanimous. Motion Carried.

Motion by Smeenk Second by Hansen to approve the bills for payment. Vote Unanimous. Motion Carried.

Motion by Hansen Second by Smeenk to accept the VSO report for May 2010. Vote Unanimous. Motion Carried.

Motion by Smeenk Second by Harms to approve the following travel request: Head Dispatcher Dallas Ford to attend a Power Phone Advanced Law Enforcement Dispatch Training in Colstrip, Montana on July 27 – 28, 2010 at an estimated cost of \$594.00. Vote Unanimous. Motion Carried.

There were no abatements.

Department Heads reported on undertakings within their respective offices.

Mr. Joe Bunnell stopped by to visit with the Commissioners about the Northern Hills Recycling Center which is known as Lazy B Enterprises. The business is located west of Belle Fourche on Highway 85.

Mr. Bunnell also visited with the Commissioners about the remaining amount of \$750.00 he owes to Butte County regarding the highway surplus items that he had previously purchased. Mr. Bunnell stated he will need some additional time before he can pay the \$750.00. The Commissioners will visit with State's Attorney Tim Vander Heide regarding this matter and let him know of their decision.

Richard and Linda Meyer and James Meyer came before the Commissioners to discuss maintenance on the Kinghorn Road. The Kinghorn Road is a Minimum Maintenance Road.

Motion by Smeenk Second by Hansen to approve an Application For Occupancy On The Right Of Way Of County Highways for Randy Stark to trench a livestock water line on the Erk Road. Vote Unanimous. Motion Carried.

The Streambank Stabilization on the Rathbun Road was discussed. Highway Superintendent Don Adams informed the Commissioners that the Road cannot be found on the Highway Road System. Therefore the project will be between Mr. Dave Rathbun and the Watershed Coalition. Butte County is not responsible for the Road.

The Commissioners directed Highway Superintendent Don Adams to send a letter via certified mail to Mr. Wes Ginsbach stating that Ollila Road or also known as Knutson Road was removed from the Highway Road system. Butte County is not responsible for the maintenance of the Road.

Highway Superintendent Don Adams informed the Commissioners that he will be ordering Mag Water in the near future. As in the past Mag Water will be delivered to those that has ordered Mag Water and payment will be required at the time of delivery.

MidState Reclamation is to begin the Milling Project on the North End of Helmer Road the week of June 7, 2010.

Butte County Sheriff Fred Lamphere was unavailable. His activity report will be presented at the June 19, 2010 meeting.

The Commissioners recessed at 11:50 a.m. with the public invited.

The Commissioners reconvened at 1:35 p.m. with all Commissioners present.

Chairman Kling called the meeting back to order and thanked Commissioner Kindsfater for his assistance in the morning.

Motion by Hansen Second by Smeenk to go into an Executive Session at 1:37 p.m. regarding legal, contractual and personnel matters. Vote Unanimous. Motion Carried. State's Attorney Tim Vander Heide was present for the Executive Session.

Motion by Hansen Second by Kindsfater to authorize State's Attorney Tim Vander Heide to execute final release and assignment in connection with claim against former Treasurer Dee Schuldies against her CNA surety bond in the amount of \$58,818.94. Vote Unanimous. Motion Carried.

Marian Atkins from the Bureau of Land Management and Elaine Raper – District Manager for the Eastern Montana/Dakotas District came before the Commissioners to provide them with a BLM Update.

WHEREAS, The United States Ellsworth Air Force Base is proposing an expansion to its Powder River Training Complex, and

WHEREAS, the citizens of Butte County and the Board of County Commissioners support and understand the importance of the training that takes place at Ellsworth, but there is concern regarding safety if the expansion is approved as proposed, and

WHEREAS, the Commission is concerned about the safety of local pilots that regularly fly within the airspace contemplated by the expansion for ranching and agricultural purposes, and

WHEREAS, the Commission is concerned that the 500 foot ceiling contemplated by the US Air Force would disrupt the day to day agricultural operations in Butte County, and

WHEREAS, the Commission is concerned about the fire dangers that exist when flares are discharged and chaff fibers are released from US Air Force aircrafts, and

WHEREAS, the Commission is concerned about the level of advance notification offered by Ellsworth and whether such notification is effective in warning Butte County residents and local pilots of Air Force planes flying over Butte County.

NOW, THEREFORE, BE IT RESOLVED that the Butte County Board of Commissioners express concern about the proposed expansion of the Powder River Training Complex within the boundaries of Butte County, as it is the County's responsibility to protect the safety and livelihood of the citizens of Butte County.
