Livestock

We deal with many, many calls concerning livestock out on the highways. While we try to keep a contact list updated for landowners, over time it has become incomplete and outdated and it is quite time-consuming to find the correct landowner. If you have livestock along Hwy 212, Hwy 85, Hwy 79, or Hwy 34 in Butte County (or if your livestock on any other road is prone to escaping), please call us and let us know the area the livestock is pastured along (mile markers are the best tools to help us locate the area) and the contact numbers (home and cell phone) for anyone responsible (owner, hired hand, or foreman) for the livestock.

Business Contact Information:

The Butte County Dispatch Center, in Belle Fourche, is the contact for all law enforcement and emergency services within Butte County. Because we operate 7 days a week, 24 hours a day, while most businesses are closed, it becomes imperative that we have emergency contact numbers for ALL businesses within our county. Even if your business is operated out of your home, or if your business is open 24 hours a day, our agency needs to have phone numbers to contact a representative in case there is a problem. Examples of situations where dispatch may need this information, would be a fire in or near your business, or perhaps a situation at your business, where the employee is incapacitated; we need to know who to call.

The information we receive is entered into our business directory and is only accessed when we need to make contact with someone from a Butte County business. These emergency contact numbers are NOT released to anyone except Law Enforcement, and Fire/EMS personnel. Many times it will be the dispatcher who will contact you and advise you of the nature of the emergency at your business.

The Butte County Dispatch Center is in the process of updating our business directory, and would appreciate a call advising your business contact information. The dispatch center can also mail or fax a short form to your business, or you can stop by dispatch and fill out the form. We are requesting information from businesses in all of our communities-including Belle Fourche, Newell, Nisland, Vale and Fruitdale. Employees change, and locations may differ, and we appreciate your assistance in helping us update our information.
