## What Counties Can Do To Better Educate Students About County Government

When educating today's youth about the importance of county government it is important that counties inform students of the functions and responsibilities of this branch of government. The role of county government is to deal with the matters concerning its citizens such as taxing, recording, financing, and maintenance at each department. Students should realize the huge responsibility each office carries throughout the ordinary business day. Students also need to be more informed of the programs and services that are available to them at the county level. Not only the programs they can benefit from but also ways they can aid in the success of these programs. Important services include the county health office along with social services such as the ICAP program and food pantry. These programs have the potential to benefit all citizens in the community especially those who are disabled or elderly or even those who are having financial hardship.

To achieve the goal of educating students about their local county government, action must be taken. Implementing programs to include students in the function of government is key. In order for students to take action and get involved, programs must be implemented to include them, such as Student Government Day.

Student Government Day would include a mock election of county officials. Before elections, each

student would have to know and understand each position they are voting for. Each student would have to be educated in the workings of the office they are campaigning for. It would also be beneficial to take a tour of the courthouse and see firsthand the responsibilities of each county office and its importance. Attendance at commissioners meetings would also be another was to show students the many decisions that arise in the process of maintaining our county.

Patty McGee donated \$200 in memory of her son Brad McGee.


Kathleen Flakus donated \$250 in memory of her husband Larry Flakus.

Association members hold various fundraisers throughout the year to raise the scholarship funds.



## National Association of Counties NACo Board of Directors Approve Changes to Governance Structure

The NACo Board of Directors, meeting at the Western Interstate Regions Conference in Umatilla County, Ore. May 21, made significant changes in the association's governance structure, approved a dental discount program, and chose three sites for future Annual Conferences.

The changes in the governance structure included reducing the number of elected officers from five to four and adding four regional representatives to the NACo Executive Committee. The changes, which were recommended by the NACo Task Force on Governance and Structure offer a nine-month review, also included guidelines for the election of officers.

Some of the 11 recommendations can be implemented immediately. Others require amending the bylaws and must be approved by the NACo membership in a vote at the Annual Conference.

The three sites chosen for future Annual Confer-

ences are Tarrant County (Ft. Worth), Texas for 2013; Orleans Parish (New Orleans), LA. for 2014; and Mecklenburg County (Charlotte), N.C. for 2015.

The methods of research have developed over the years from frontier days when everything was hand recorded, then filming documents and providing copies electronically, to digitally scanning documents to computers which made recording and copying documents for the public much easier.

Frances Larsen has many accomplishments to her credit. She was instrumental in developing "same day turn around" on all documents. The new "Scanfile System" has made remarkable changes in the operation of the Register of Deeds Office. She credits a lot of changes to the motivation of five (5) remarkable deputies during her 30 plus years as Register of Deeds.

Frances is highly regarded for her many contributions and support for the Beacon Website development for Custer County. Her library skills were exceptionally valuable researching the data needed from the Register of Deed's Office.

Frances served on the South Dakota Association of County Officials (SDACO) as its 2<sup>nd</sup> Vice President and Group Leader before they had a Director of the Association. She served as a SDACO board member. Her greatest privilege was to know the many elected officials statewide, many of whom have become lifelong friends and mentors. Frances was a committee member to honor Governor George Mickelson after he lost his life in an airplane crash. A Chapel in the Youth

Forestry Camp in Custer State Park was built to honor him.

Frances has been a member of the Custer County Republican Central Committee as an elected official and State Committee Woman. She was a charter member of the Custer County Republican Women. Frances served as Custer County Republican Women's president and program chairperson. She enjoyed having tea at the "old" Governor's Mansion. She sat in on legislative committees during session supporting legislation for counties.

Frances has also served in many other organizations. She was the 1<sup>st</sup> Chairperson for the Custer "After 5" organization sponsored by "Stone Craft Ministries for Christian Business Women". She served 11 years as a 4-H Leader. Church member of Liberty Baptist Tabernacle for 22 plus years. She was the Treasurer for many years for Southern Hills friends of N.R.A.

One of Frances's many favorite songs describes how she feels about her career as the Register of Deeds (I am a Patriot): "This Is My Country" the "GRANDEST ON EARTH". ## Are County Investments Safe? By Deene Dayton

With today's market in a turmoil, is each county comfortable with how their investments are sitting?


County investments start with a well grounded investment policy that is required by SDCL 4-5-8. Have you recently reviewed your county's policy to ensure that it fits today's investment practices?

Some of the areas that are relevant to an investment policy are, A. types of investments, B. where to invest, C. interest earned, D. who does the investing, E. pledging collateral, F. periodic reports from the treasurer, and, G. specific investment strategies.

For those counties that invest in mutual funds and government backed securities, their investment policy should also consider credit risk, custodial credit risk, concentration and interest rate risk.

Are you diversified? Do you have all your eggs in one basket? Will cash be available when needed (laddering)? Are you chasing rates? Higher rates mean higher risks. Have you checked the DLA website for banks that have not sufficiently pledged collateral?

Some recent tools in the investment arena are CDARS and sweep accounts. Make sure that you fully understand the pros, cons and risks of any investment before participating.
