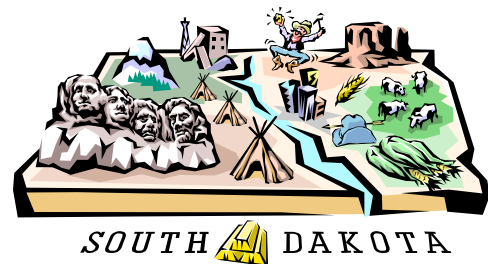

We anticipate the Deputy Workshop will be held shortly after the Spring Workshop. Any ideas or comments you have for the workshop would be greatly appreciated. A survey will be sent out next month to get your feedback on the format and sessions for the Deputy Workshop.

We are also working on improving the number of options available for you to meet your elective credit requirements. At convention four elective credits were available, you receive one credit for each district meeting you attend, and elective sessions will be available at the Spring Workshop. In each newsletter we will also list other options for you to get additional elective credits.

Officials may also choose to submit other coursework relevant to their duties as a county official completed outside the SDACO to the CEC for approval as elective credits. Classes completed independent of SDACO workshops or other pre-approved elective courses require a report on the benefits the class has to the duties of a county official.

Elective credit classes must be beneficial to the ongoing duties of an elected county official. The Continuing Education Committee has the authority to determine if a class qualifies for credit under the SDACO Certified County Official Program.

Pre-approved elective courses include sessions at workshops administered by the SD Secretary of State, SD Department of Legislative Audit, SD Department of Revenue and Regulation, SD Department of Health, SD Association of County Commissioners, SD Association of County Welfare Officials, Software User Meetings, SD Professional Land Surveyors' Association, International Right of Way Association, the National Association of Counties (NACo), the National Association of County Recorders, Election Officials, and Clerks (NACRC), the National Association of County Collectors, Treasurers and Finance Officers (NACCTFO).

With each issue of the *South Dakota County News* we will list an opportunity for you to earn elective credits.

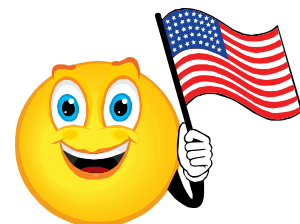

Once you go to the site, click on the software you would like to learn more about. For many of the selections there are multiple choices. When you click on a session it will tell you the approximate time the session will take. Print out this page for your records. The sessions work like a PowerPoint slide show and will allow you to pause if you need to.

Elective credits are awarded as one hour in session = one credit. For example, a 45 minute session on this website would equal .75 credits. Please contact the SDACO office if you have any questions.

Property Record Industry Association/Prep Chapters

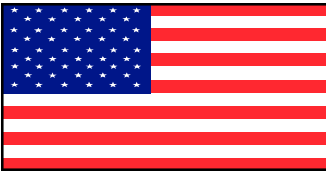
This past summer I had the opportunity to be able to attend the national Property Records Industry Association's (PRIA) national conference in Spokane, Washington. PRIA is a national organization comprised of county recorders (Registers of Deeds, County Clerks) as well as property records professionals from the private sector, such as financial lenders, title abstractors, realtors, technology providers, bulk sales representatives, etc. PRIA provides its members with consistent and timely updates concerning property records issues, as well as providing opportunities for business and government to work together, communicate (sometimes debate), and pursue legislation concerning important matters that affect us all by state, as well as on a national basis. I listened to debate concerning bulk sales issues, received valuable information regarding redaction, e-recordings and effective legislative procedures, attended a records retention and archiving presentation by a nationally known archivist, and discussed many of the same difficult issues that exist in every state.

One of the ways in which PRIA brings government and record industry businesses together is by sponsoring Property Records Education Partners (PREP). The PREP chapters provide a structured forum and procedure to help governmental offices and private industry sectors to work effectively at the local level concerning a long list of important issues that affect us today. Technology is one such issue, which challenges and affects us all as the property records industry expands. Reliable information and meaningful dialogue between county recorders and property records professionals is imperative in order to enable

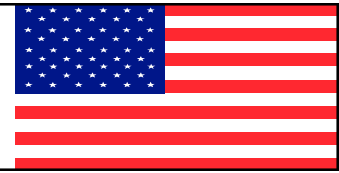
us to make informed decisions if we are to keep pace and continue to meet the needs of our constituents.

PREP chapter meetings help develop better communications and understanding between local property records industry partners. The comments that I have heard repetitively have been, "The meetings are so interesting. We can clearly benefit from each other." PREP chapters provide the opportunity for us to discuss local and state issues in order to resolve problems quickly and effectively. PREP meetings also allow local, state and national law-enforcement, as well as other agencies, to provide important information and share areas of concern relating to land fraud, privacy issues and other pertinent matters as they arise. By working together, we will all gain more knowledge, resolve more problems, meet new challenges and better serve our counties, our state and our nation.

I have been in contact with an attorney, who is in-house counsel for one of the title companies in Minnehaha County, who recently attended a PREP chapter meeting in Omaha, Nebraska. He indicated it was a very interesting, informative meeting, with significant participation from the FBI as well as several people in the housing and property records industries. We anticipate organizing a PREP chapter within the next few months. I encourage you to contact PRIA and explore the opportunities that are available to you through membership and through the establishment of your own PREP chapter.



National County Government Month



More counties will have the opportunity to participate in National County Government Week activities in 2010, when the observance expands from a single week in April to the entire month — henceforth to be known as National County Government Month.

NACo's Executive Committee decided to expand National County Government Week to a month to give counties more options to schedule activities that raise public awareness and understanding of county government.

National County Government Month (NCGM) will be held in April in 2010 and future years.

“By designating each April as National County Government Month, counties will have greater flexibility to plan and schedule their own county government activities,” said NACo President Valerie Brown. “Counties aren't expected to hold public awareness activities throughout the month, but can schedule activities any time during the month.”

Previously, a county government week with fixed dates fell at an inconvenient time for some counties, according to feedback the Executive Committee received.

First celebrated in 1991, National County Government Week (now National County Government Month) was created by NACo to raise public awareness and understanding about the roles and responsibilities of the nation's 3,068 counties. The community outreach events help residents and businesses better understand how counties serve the community.

A booklet of ideas and suggestions on how to celebrate NCGM will be available early next year. It will also provide helpful information about media outreach strategies and NACo's online NCGM Media Resources Kit.


